Purpose of Recordings	:	

SATS Ltd. and/or its subsidiaries ("SATS") agrees to grant the Licensee specified above a limited licence ("Licence") to enter its premises on such date(s) mutually agreed and to further film, capture, take or record images, photographs, films, videos, audio recordings, sounds and the like ("Recordings") at such premises strictly on the following terms and conditions:

- Some of SATS' premises are designated as "Protected Infrastructure" under the Infrastructure Protection Act 2017 (Act 41 of 2017). Accordingly, SATS reserves all rights to require Licensee to comply with all rules, regulations and requirements that SATS may implement from time to time to safeguard the security and safety of all of SATS' premises, including but not limited to the right to require Licensee's officers, employees and agents to vacate SATS' premises at any time at SATS' absolute discretion.
- 2. Licensee shall be solely responsible for the safety of its officers, employees and agents while they are at SATS' premises, and shall indemnify SATS for any and all actions, proceedings, claims, damages, costs, expenses, losses, damages or inconveniences of any nature whatsoever arising out of any injury sustained by Licensee's officers, employees and agents arising out of or in relation to any injury, illness or condition suffered by their officers, employees and agents while at, or on the way to or from SATS' premises.
- 3. Licensee's officers, employees and agents who wish to enter SATS' premises will be required to furnish certain personal data to SATS for SATS' collection, use and disclosure for security purposes. SATS will comply with the requirements of applicable data protection laws in connection thereto. If Licensee's officers, employees and agents do not consent to SATS' collection, use or disclosure of such of their personal data, such individual(s) shall not be allowed to enter SATS' premises.
- 4. Licensee represents, warrants, undertakes and procures that it and its officers, employees and agents shall not interrupt, disrupt or in any way interfere with any operations carried out at SATS premises without SATS' prior consent. If, due to any act or omission on the part of Licensee's officers, employees and agents, any property, fixture, fitting or equipment at SATS' premises including but not limited to any flooring, interior plaster, door, wall, ceiling, window, lock, pillar,

wire, cable, pipe, installation, machine and vehicle is damaged or lost, Licensee undertakes to, at its costs and expense, repair, restore, remedy or replace the same to SATS' satisfaction.

- 5. All intellectual property rights in all Recordings filmed, captured, taken or recorded by Licensee and its officers, employees and agents while they are at SATS' premises shall belong to Licensee solely, except that Licensee may only use the Recordings for the sole purpose of recordings as indicated in the table above, and not for any other purpose. If Licensee wishes to reproduce or use the Recordings outside of the limited purposes specified herein, Licensee shall seek SATS' prior written consent prior to such use or reproduction.
- 6. Without prejudice to the other terms and conditions set out herein, the Licensee shall indemnify SATS for any and all actions, proceedings, claims, damages, costs, expenses, losses, damages or inconveniences of any nature whatsoever that SATS and/or any other party may suffer or incur in connection with the Licence granted by SATS.
 - 7. SATS may, at its absolute discretion, revoke all or part of the Licence granted herein by written notice to the Licence without having to provide any reason or explanation thereto.
